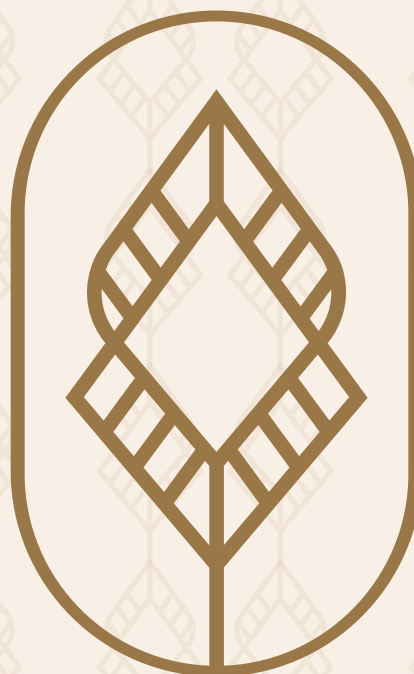

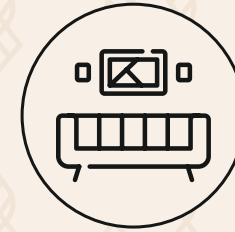
TYPICAL FLOOR PLAN



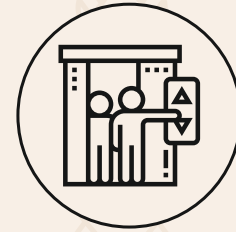

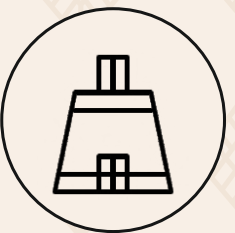

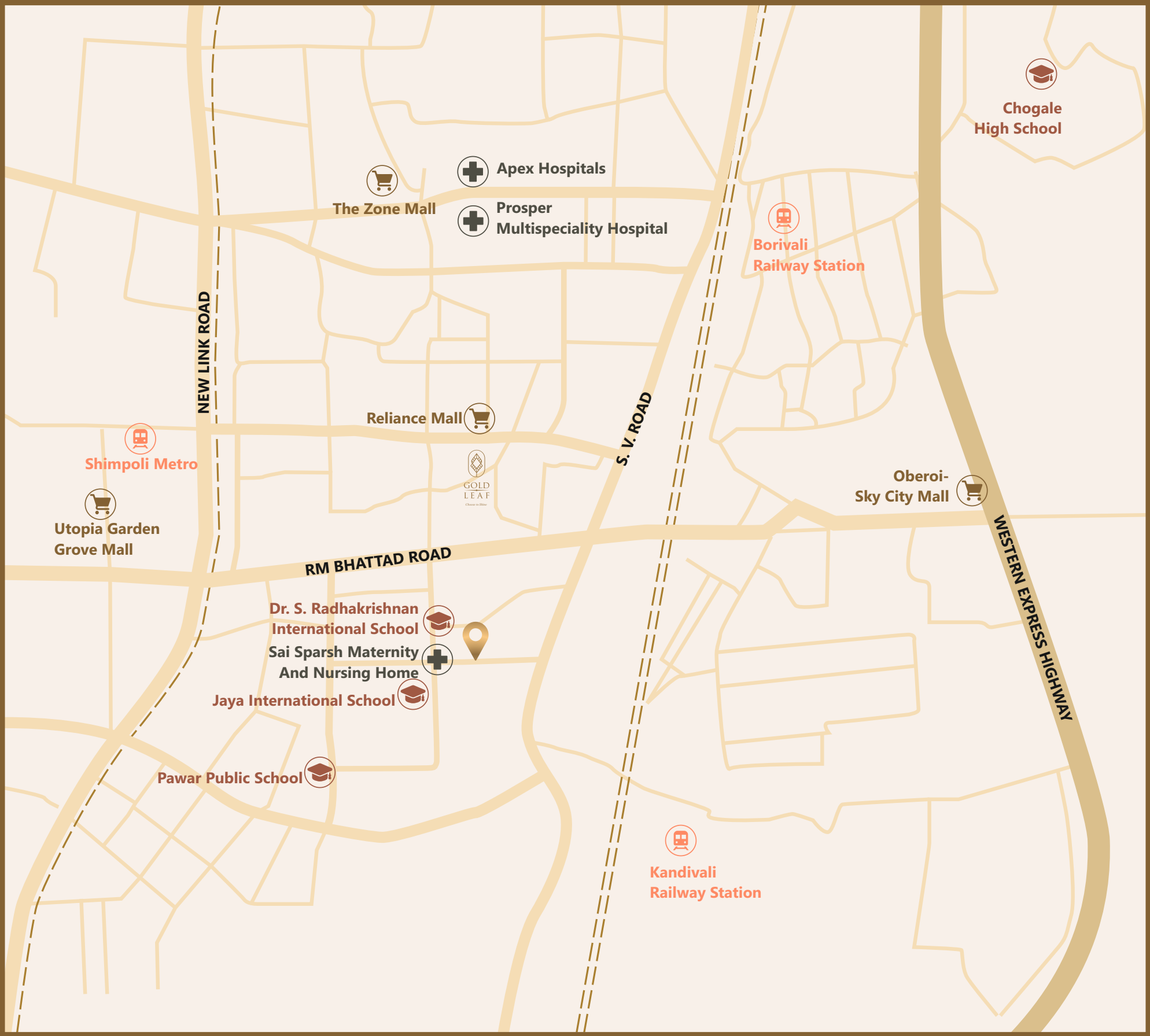
